- 2. CSEW Activities Update-CSEW is next week, May 20-24, 2019
  - Sherie distributed copies of the Calendar of Events for CSEW week. There will be raffles during the week for CSEA tee shirts and water bottles. Cindy will bring pizza to the night custodians on Monday night. Beth will purchase non-dairy frozen treats for the Ice Cream Social on Thursday. Sherie will be the point person during CSEW week since Cheryl and Rob are out spending time with their newborn. Sherie has also given 3 new member orientations to newly hired classified staff and will give another one during CSEW week.   - Liz mentioned that some of the things being discussed at the next Negotiation meeting include Article 13-Safety, Overtime Form, Telecommuting, Vacation Article, Article 7 Hours, and Classified teaching as Adjuncts. Classified will be allowed to teach as adjuncts as long as they notify their supervisor and do not teach during their normal work hours and the classified staff wanting to teach has a satisfactory evaluation on file from supervisor.
