

According to Santa Barbara Community College District Board Policy and Administrative Procedure 5011, eligible Dual Enrollment students may enroll in a maximum of 11 college units in the Fall and Spring semesters to enrich their educational experience.

Dual Enrollment students demonstrating advanced scholastic standing may appeal AP 5011 which limits enrollment to a maximum of 11 semester units. The appeal, if approved, would allow a Dual Enrollment student to enroll in excess of 11 units. Students that enroll in excess of 11 units may be assessed and required to pay the per unit enrollment fee for all units enrolled.

# Step 2: The criteria and documentation for requesting to appeal BP 5011 are:

- Student must establish and maintain a minimum GPA of 3.0 with no grade below a "C" in an academic class (student must provide a high school transcript and a college transcript, if available).
- Student registering in over 11 units will be subject to payment of all enrollment fees in addition to mandatory fees if applicable. Attach a list of the courses and the total units in which you would like to register.
- As the student, I acknowledge that the appeal and approval process is SBCC term based and a new petition form along with documentation is required every semester.

## **Step 3: High School Counselor**

I have met with the student and parent to review their course load and provide advice about the max unit requirement.
