Carola provides a brief summary of the three programs that submitted Request for Proposals and Budget Sheets. The total award allocation was \$117,600.00. Carola relays that two programs, the SBCC NC Adult High School GED and SBCC English as a Second Language meet all of the requirements and highlights how both programs' plans will enhance their existing programming efforts. She relays that the School of Extended Learning is highly interested in transforming the current admissions process to a mobile platform. While the Mobile Technologies request for proposal meets this need, more time is needed with the SBCC credit campus to identify a specific platform, therefore, she recommends the Mobile Technology, or another entity, reapply for the next grant cycle when further collaborations and plans are made with our SBCC credit admissions partners. Submissions included:

- iii. Mobile Technologies
