Andy Gil made a motion to approve the minutes. There were no changes needed to the minutes, so they were approved.

A <u>statement from Akil Hill</u>, who was unable to attend today's meeting, was read to the committee members.

There were concerns raised about funding that SBCC receives as an HSI, and how that money is allocated. The SEA co-chairs attempted to clarify that SEA funding is tied to the goals of the Student Equity Plan. As directed by the Chancellor's Office, the goal is to focus on a very specific group to see if we can actually make an impact. As indicated in the Student Equity Plan, Black and African American students are the most disproportionately impacted students at SBCC, and have the lowest completion and success rates. The 2022-2025 Student Equity Plan aims to improve those rates for this particular student population.

The committee determined that since there will most likely not be a lot of SEA one-time funding available (potentially \$75,000), that the money should be awarded to the Umoja program in order for the work outlined in some of the One-time proposals that were submitted to be furthered in a way that will not create additional silos, but rather in a centralized process to further the success of SBCC Black/African American students. Co-chair Byrne noted that Umoja is one of the least funded programs.

Co-Chair Muschamp displayed a spreadsheet with the 23 proposals on the screen, and the committee decided which of these three options (or combination of options) should be given to each proposal. The three options were:

- Umoja Collaboration
- Alternative Funding
- Does not align with Student Equity Plan

Proposal Spreadsheet with 3 Options

Results:

13 proposals: Umoja Collaboration/Alternative Funding**2 proposals:** Umoja Collaboration**8 proposals:** Alternative Funding

Noting that the process the committee went through today was different than what was done in the past, the co-chairs invited the committee to take time to process everything, and to send them an email on their thoughts...

The co-chairs made a commitment to start some of the research into alternative funding sources. The co-chairs will set up some dates in the summer to start working on this, and they will invite committee members, just as was done for the 2022-2025 Student Equity Plan. They will also work on restructuring the SEA committee during summer as well.

The committee decided to vote on granting up to \$100,000 to Umoja. If there are remaining funds available, the co-chairs will contact the SEA members. The co-chairs are meeting with Cheryl Brown on Thursday to see what the totals are now.
